Performance Fund vs Benchmark

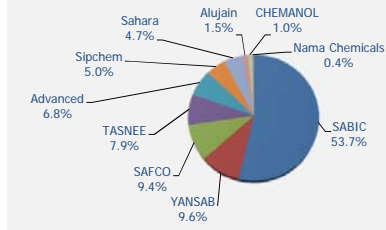
