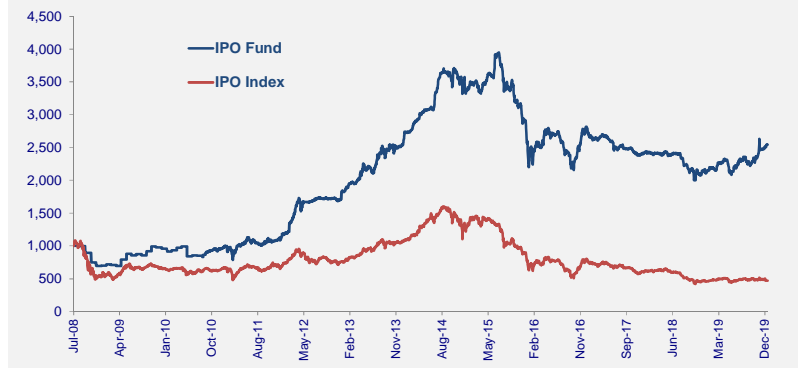

**Performance Fund vs Benchmark**

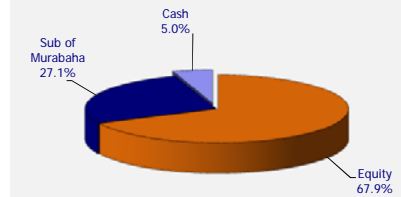
