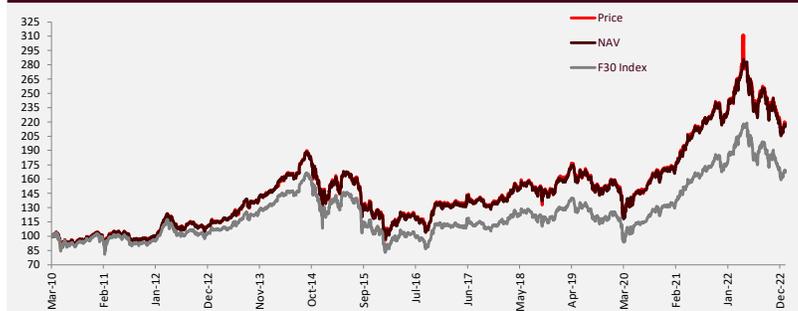

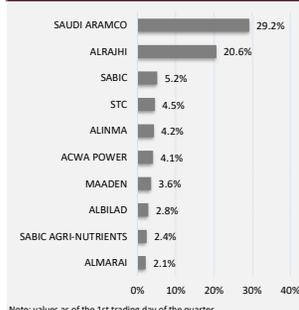

Performance Fund vs Benchmark

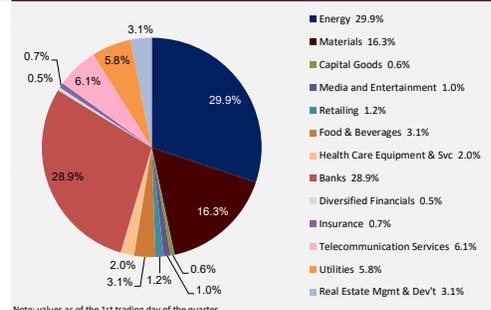


Top 10 Holdings
