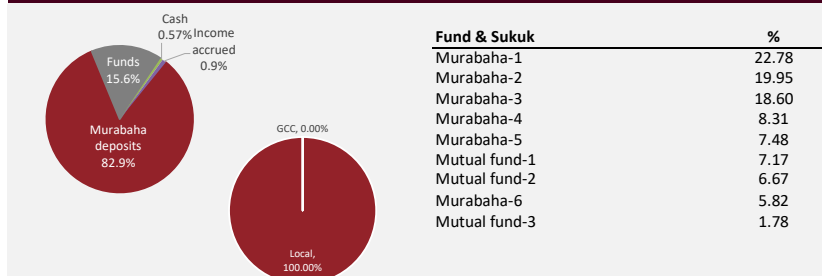
Performance Fund vs Benchmark
